NOTICE IS HEREBY GIVEN that City of West Wendover Ordinance No. 2009-02, with Summary and Title as follows, was filed with the City of West Wendover Clerk on January 20, 2009:

SUMMARY - WEST WENDOVER ORDINANCE NO 2009-02 AMENDS THE CITY CODE GOVERNING FINGERPRINT-BASED BACKGROUND INVESTIGATIONS AS REQUIRED BY THE CITY TO COMPLY WITH CONDITIONS TO CONTINUE CITY USE OF THE FEDERAL BUREAU OF INVESTIGATIONS AND ITS NATIONAL RESOURCES IN CONDUCTING REQUIRED INVESTIGATIONS AND PROVIDES MATTERS APPROPRIATELY RELATED THERETO.

TITLE - WEST WENDOVER ORDINANCE NO 2009-02, AN ORDINANCE ENTITLED "FINGERPRINT SUBMISSION CODE SECOND AMENDMENT", WHICH AMENDS THE CITY FINGERPRINT CODE TO MAKE CHANGES FOR ADDITIONAL SPECIFICITY TO COMPLY WITH NEW REQUIREMENTS OF THE FEDERAL BUREAU OF INVESTIGATIONS CONCERNING FINGERPRINT SUBMISSIONS WHEREVER SUCH ARE REQUIRED BY CITY CODE OR RESOLUTION OF THE COUNCIL FOR BACKGROUND INVESTIGATIONS IN LICENSING AND OTHER PERMISSIBLE CATEGORIES OF SUCH INVESTIGATION.
