Roll-Off - 30 yard container **\$425.91** dump and return, plus tipping fee. (Tipping fee is **\$109.54** per ton.) **\$4.87** rental per day.

**LANDFILL ACCOUNT - \$109.54 PER TON CONSTRUCTION DEBRIS (\$33.87 CLEAN DEBRIS)**

Front Load:

3 yard- **\$153.31**/month, once a week service

4 yard- **\$204.40**/month, once a week service

8 yard- **\$408.83**/month once a week service

**Additional dumping fees will be charged for service in excess of once per week**

1. Frontload containers require an 8' x 10' cemented pad at ground level, or we will not be responsible for wheel damage.
2. Containers shall not be overloaded. If so, we will off-load, and an overload fee will be assessed.
3. Containers shall not be moved by customer. Any damages will be repaired and charged to customer.
4. Containers shall not be used for dirt, rocks, hot ashes, any type of animal carcass or toxic materials (i.e. paint, cleaning solvents, asbestos, oil, ect. If contaminants are found, it will be the responsibility of the customer to have it removed and cleaned).
5. We will not be responsible for blocked containers by cars, snow etc. A fee will be assessed for return trips.
6. The City of West Wendover will not be responsible for cleaning of containers.
7. If container is destroyed, i.e. fire, etc, the customer will be responsible for replacement at the current rate.
8. Penalties will be assessed on all overdue accounts at a rate of 10% of total balance for the first month and an additional 1.5% per month thereafter.
9. Any returned check must be reimbursed to the City with cash, money order or certified check only. There will be a fee of \$20.00 for each returned check.

By signing this application, applicant agrees to comply with City garbage regulations, including any future Amendments adopted by the City Council in a regular scheduled City Council Meeting. Applicant further agrees to pay Garbage bills promptly.
